The bid information will be available online from the PISD website and from the Palestine ISD Business Office located at 1007 East Park Avenue, Palestine, TX, 75801 on August 4, 2017, and bids will be received at the PISD Business Office located at 1007 E. Park Ave, Palestine, TX 75801 until 10:00 AM local time on August 18, 2017.

Sealed bid envelopes should be marked "2017-2018 Motor Fuel Products Bid". Any bids received in any other manner other than in a sealed envelope shall not be considered. Any bid received after 10:00 AM, August 18, 2017, shall be disqualified. Palestine ISD reserves the right to contact bidder after the opening of the bids to clarify any questions the PISD might have. However, no bid adjustments will be allowed. Bid awards are expected to be made at the August 21, 2017 Board meeting of the Board of Trustees. However, PISD reserves the right to adjust the award date and will notify all parties that have submitted a qualified bid of any change to the award date at the earliest possible time.

Bids may be submitted on any/all times contained on the bid sheet. The PISD reserves the right to reject any or all bids and to accept the bid deemed most advantageous to the PISD. The PISD also reserves the right to wave any formalities in the bidding process. The PISD reserves the right to award all or part of the bid to multiple bidders.
