## **Special Spotlight**

The Board of Trustees expressed their appreciation to **Superintendent Dr. Thomas Wallis, wife Nicole, and sons Luke and Hunter**. Board of Trustees President, Wade Hobbs presented a plaque to Dr. Wallis and thanked him for his faithful service, love and commitment to Palestine ISD. The Board wished Dr. Wallis and his family the best as they begin a new journey in Bryan, Texas, where Dr. Wallis will serve as superintendent of schools for the Bryan Independent School District.

# **Recognition of Lee Parkinson**

Superintendent Dr. Thomas Wallis expressed his appreciation to KYYK 98.3 General Manager, **Lee Parkinson** for his support of the school district. He also presented a certificate naming Mr. Parkinson to the 2011 Media Honor Roll, a program sponsored by the Texas Association of School Boards. The Media Honor Roll recognizes media representatives who deserve recognition for fair and balanced reporting of news about public schools.

### **Construction Projects Update**

Walt Wood of Claycomb Associates, Architects provided the Board of Trustees an update of the construction progress.

Of the original Phase 1, 2, and 3 construction projects, all are now primarily finished except for Palestine High School. Phase 1 consisted of the renovations of Wildcat Stadium, the A.M. Story Intermediate track, the Palestine ISD Administrative Offices, and Washington Early Childhood Center and Daycare. Phase 2 included the construction of a new gym for Palestine Middle School, new additions at Northside Primary, Southside Elementary, all of these projects have been completed. Phase 3 is currently ongoing and consists of renovations and construction at Palestine High School, these projects are 59% complete. Superintendent Dr. Thomas Wallis stated that the construction budget is in great shape financially and there will be no issue completing the projects within the allocated budget. All of these projects were made possible by the tax payers of Palestine Independent School District who voted for and passed a bond in the spring of 2009.

## 2012 Anderson County Appraisal District Proposed Budget

David Atkeisson, Director of Business Services, reviewed the Anderson County Appraisal District proposed budget for 2012. Mr. Atkeisson stated that the total budget reflects a reduction of 1.25% from the 2011 approved ACAD budget.

### **Financial Update**

David Atkeisson, Director of Business Services, informed the Board of Trustees that the District has collected about ninety-five percent of the current year taxes and about ninety-two percent of the prior year delinquent taxes. These should continue to rise over the next several months. The District has received approximately seventy-seven percent of the general revenue budget and has expended approximately seventy percent.

### 2011-2012 Budget Information

David Atkeisson, Director of Business Services, stated that he was not yet able to present definite budget information for 2011-2012 due to the senate still being in special session. The District is expecting a reduction of approximately 1.3 to 1.5 million, however the reduction could be more or less than the anticipated amount. District administrators and campus principals have reviewed their budgets and made reductions in preparation for the expected budget shortfall.

Story Intermediate campus, a successful first year for the Washington Early Childhood campus and daycare, much improved athletics and technology programs, a new gym for Southside Elementary students who had taken PE classes in a portable building during the construction process, and new and improved facilities throughout the District.

Dr. Wallis thanked the Board of Trustees for a great three years. He complimented the Board for their focus always being on what is best for the students of Palestine ISD. He expressed that his experiences at Palestine have been humbling and it has been an honor to work with a fantastic Board for the students of Palestine ISD, because our kids deserve the best!

Dr. Wallis also thanked Suzanne Eiben, Assistant Superintendent of Human Resources, for doing a remarkable job over the past year in working with District administrators and principals to plan for the expected budget shortfall.
